# Rules for the Issuance and Administration of the Directory of Payment System Codes in the Czech Republic (ČKPS)

#### Article I

#### **Basic provisions**

- 1. Pursuant to Article 38(4) of Act No. 6/1993 Coll. on the Czech National Bank as amended, the Czech National Bank (hereinafter the "CNB") stipulates these Rules for the Issuance and Administration of the Directory of Payment System Codes in the Czech Republic (hereinafter the "ČKPS Rules").
- 2. The ČKPS Rules define the CNB's rules for determining and assigning the payment system codes of payment service providers<sup>1</sup> and the CNB's procedures for issuing the Directory of Payment System Codes in the Czech Republic (hereinafter the "ČKPS Directory") and for administering it in accordance with Article 6(2) of Decree No. 169/2011 Coll. on the rules for the creation of account numbers for making payments.

#### Article II

#### Payment system code

- 1. The payment system code is a number that uniquely identifies a payment service provider in the Czech Republic. The payment system code consists of four digits.
- 2. The CNB shall assign a payment system code to entities that execute or wish to execute payments in the Czech Republic and need a payment system code for such activities, or will use the payment system code for other purposes arising from a special legal rule<sup>2</sup>.
- 3. An entity that requests a payment system code should submit an application in writing to the CNB, including its reasons for applying and a description of the activities that it carries on or wishes to carry on.
- 4. The CNB shall assign the payment system code taking into account items 2 and 3. The CNB does not assess the application in administrative proceedings pursuant to the

Administrative Procedure Code. There is no statutory right to the assigning of a payment system code.

- 5. With the CNB's consent, a payment service provider may hold several payment system codes where necessary for the provision of its services (for example, the temporary coexistence of codes after holders merge).
- 6. The payment system code is linked to the payment service provider. Rights to the payment system code are not contractually transferrable to any other entity and the payment service provider may not sell the assigned payment system code or allow others to use it.
- 7. The CNB shall delete the payment system code from the ČKPS Directory upon the dissolution of the payment service provider at the request of the payment service provider or by agreement with the payment service provider where the payment service provider has ceased to provide the payment system services for which it used the payment system code.

# Article III

#### **ČKPS Directory**

- 1. The CNB shall issue the ČKPS Directory in text form (an example is given in the annex) and shall publish it on its website <a href="https://www.cnb.cz">www.cnb.cz</a> in the Payments section.
- 2. The ČKPS Directory contains the payment system code, the name of the payment service provider, the BIC<sup>1</sup> code of the payment service provider, and information about its participation in the CERTIS payment system<sup>2</sup>.
- 3. The CNB shall issue the ČKPS Directory whenever its content changes (e.g. new payment system code, change in name, merger or dissolution of payment service provider), usually as of the first day of the month. The CNB shall publish the ČKPS Directory well before it enters into force.
- 4. The CNB shall describe the changes in the new version of the ČKPS Directory compared to the previous version in a list of changes to be issued in a single document together with the ČKPS Directory.

Payment system code	Code number assigned to a payment service provider by the Czech National Bank in accordance with Article 6 of Decree No. 169/2011 Coll. on the rules for the creation of account numbers for making payments.
	The code is used when creating the account number in national format and in IBAN format and is used for unique identification of the account.
	The code is also used when performing domestic interbank payments (the CERTIS system) or for other purposes stated in the Rules for the Issuance and Administration of the Directory of Payment System Codes in the Czech Republic.
Payment service provider	Commercial name or designation of payment service provider
BIC code (SWIFT)	BIC (Bank Identifier Code) – payment service provider's SWIFT address – code assigned to payment service provider by SWIFT (not used in CERTIS).
	Together with the account number in IBAN format the BIC code is used to route payments from abroad to accounts held with the provider.
