GENERAL PROVISIONS**relating to Part V of the CNB's Schedule of Charges for Financial and Business Services**

1. The CNB shall charge banks for interbank payment system operations pursuant to the Agreement on the Maintenance of Payment System Accounts and Submission of Interbank Payment System Data, and other institutions pursuant to the relevant Agreements on the Submission of Third-Party Orders.
2. Part V of the CNB's Schedule of Charges for Financial and Business Services of 1 January 2007 is hereby repealed.
